The amount included in Item 1.24 includes \$104,310 in salary and other benefits paid to the executive director, consulting fees to non executive directors of \$30,000 and \$35,675 paid in director's fees to directors and entities associated with the non executive directors during the quarter.

**Non-cash financing and investing activities**

2.1 Details of financing and investing transactions which have had a material effect on consolidated assets and liabilities but did not involve cash flows

In December 2008, the Company entered into a contract to purchase inventory for A\$5.1m which required the upfront cash payment of A\$2.0m and the entering into a secured promissory note for A\$3.1m (US\$2.15m). The promissory note is repayable on the sale of finished equipment on or before 31 December 2010 at the rate of US\$50,000 per unit sold. The promissory note is secured by part of the inventory and a guarantee from the parent Company, is denominated in US\$ and attracts an annual interest charge of 5% on the outstanding amount payable monthly.

The promissory note was repaid in full during the quarter ended 30 June 2010 and all security was discharged.
